Dear Contributor(s):

Thank you for submitting your Contribution for publication. In order to expedite the editing and publishing process and enable the Owner of the Journal to disseminate your Contribution to the fullest extent, we need to have this Exclusive License Agreement to publish in the Journal executed. If the Contribution is not accepted for publication, or if the Contribution is subsequently rejected, this Agreement shall be null and void. **Publication cannot proceed without a signed copy of this Agreement. Please download, sign and email the scanned document to the Journal Production Editor (contact details to be found via the journal's Guidelines to Authors).**

A. COPYRIGHT

1. The Contributor retains the copyright to the Contribution. The Contributor grants to the Owner of the Journal an exclusive license to publish in the Journal the Contribution during the full term of copyright and any extensions or renewals, including but not limited to the right to publish, republish, transmit, sell, distribute and otherwise use the Contribution in whole or in part in electronic and print editions of the Journal and in derivative works throughout the world, in all languages and in all media of expression now known or later developed, and to license or permit others to do so.

2. Reproduction, posting, transmission or other distribution or use of the final Contribution in whole or in part in any medium by the Contributor as permitted by this Agreement requires a citation to the Journal suitable in form and content as follows: (Title of Article, Contributor, Journal Title and Volume/ Issue, Copyright © [year], copyright owner as specified in the Journal, Publisher). The copyright in the Contribution will be held in the name of the Contributor in the Journal. Links to the final article on the publisher website are encouraged where appropriate.

B. RETAINED RIGHTS

The Contributor retains all other proprietary rights, such as patent rights, in any process, procedure or article of manufacture described in the Contribution. The Contributor and its co-Contributors retain the right to use the data/data sets accompanying any version of the Contribution as they deem appropriate, including but not limited to performing and engaging in text mining /data mining activities, and allowing others to do the same.

C. USES BY CONTRIBUTOR

1. **Original Contributor's Version.** The Contributor retains the following rights in the version of the Contribution as originally submitted for publication:

- The right to self-archive or archive in the Contributor's institutional repository at any time. This right extends to both intranets and the Internet. The Contributor may not update the submission version or replace it with the published Contribution. The version posted shall contain a legend as follows, where possible: This is the pre-peer reviewed version of the following article: FULL CITE, which has been published in final form at [Link to final article].
- The right to transmit, print and share copies with colleagues.
- The same set of rights as retained by the Contributor in 1.a. and 1.b. above is hereby granted to the Contributor's co-Contributors.

2. **Accepted Version.** Re-use of the accepted and peer-reviewed (but not final) version of the Contribution is not permitted under this Agreement. There are separate arrangements with certain funding agencies and institutions governing reuse of this version. The details of those relationships, and other offerings allowing open web use, are set forth at the following website: <http://www.wiley.com/go/funderstatement>.

3. **Final Published Version.** The Contributor retains and grants to its co-Contributors the following rights with respect to the final published version of the Contribution:

- Copies for colleagues. The personal right of each individual co-contributor to send or transmit individual copies of the final published version in any format to colleagues upon their specific request provided no fee is charged, and further-provided that there is no systematic distribution of the Contribution, e.g. posting on a listserv, website or automated delivery.
- Re-use in other publications. The right to re-use the final Contribution or parts thereof for any publication authored or edited by the Contributor or its co-Contributors (excluding journal articles) where such re-used material constitutes less than half of the total material in such publication. In such case, any modifications should be accurately noted.
- Teaching duties. The right to include the Contribution in teaching or training duties at the Contributor's or its co-Contributors' institution/place of employment including in course packs, e-reserves, presentation at professional conferences, in-house training, or distance learning. The Contribution may not be used in seminars outside of normal teaching obligations (e.g. commercial seminars). Electronic posting of the final published version in connection with teaching/training at the Contributor's or its co-Contributors' company/institution's permitted subject to the implementation of reasonable access control mechanisms, such as user name and password. Posting the final published version on the open Internet is not permitted.
- Oral presentations. The right to make oral presentations based on the Contribution.

4. **Article Abstracts, Figures, Tables, Data Sets, Artwork and Selected Text (up to 250 words).**

- Contributors may re-use unmodified abstracts for any non-commercial purpose. For on-line uses of the abstracts, the Society encourages but does not require linking back to the final published versions.
- Contributors may re-use figures, tables, data sets, artwork, and selected text up to 250 words from their Contributions, provided the following conditions are met:
 - Full and accurate credit must be given to the Contribution.
 - Modifications to the figures, tables and data must be noted. Otherwise, no changes may be made.
 - The re-use may not be made for direct commercial purposes, or for financial consideration to the Contributor.
 - Nothing herein shall permit dual publication in violation of journal ethical practices.

5. **Other Uses by the Contributor.** In addition to the rights specified as retained in paragraphs B and C above, the Contributor retains the right to make copies of and distribute the final published Contribution internally in print format or electronically on the Contributor's internal network. Copies so

used may not be resold or distributed externally. However the Contributor may include information and text from the Contribution as part of an information package included with software or other products offered for sale or license or included in patent applications. Posting of the final published Contribution by the Contributor on a public access website may only be done with written permission from the Owner of the Journal.

D. SIGNATURES, COMMUNICATION OF THE AGREEMENT TO THE JOURNAL

For company/institution-owned work, signatures cannot be collected electronically and so instead please print off this Agreement, ask the appropriate person in your company/institution to sign the Agreement in the space provided below, and email a scanned copy of the signed Agreement to the Journal Production Editor. E. GOVERNMENT CONTRACTS

In the case of a Contribution prepared under U.S. Government contract or grant, the U.S. Government may reproduce, without charge, all or portions of the Contribution and may authorize others to do so, for official U.S. Government purposes only, if the U.S. Government contract or grant so requires. (U.S. Government, U.K. Government, and other government employees: see notes at end.)

F. COPYRIGHT NOTICE

The Contributor agrees that any and all copies of the final published version of the Contribution or any part thereof distributed or posted by them in print or electronic format as permitted herein will include the notice of copyright in the name of the Contributor as stipulated in the Journal and a full citation to the Journal.

G. CONTRIBUTOR'S REPRESENTATIONS

The Contributor represents that the Contribution is the Contributor's original work, all individuals who contributed to the Contribution, and all individuals who contributed are included. If the Contribution was prepared jointly, the Contributor has informed the co-Contributors of the terms of this Agreement and has obtained their written permission to execute this Agreement on their behalf. The Contribution is submitted only to this Journal and has not been published in a journal before. (If excerpts from copyrighted works owned by third parties are included, the Contributor will obtain written permission from the copyright owners for all uses as set forth in the standard permissions form or in the Journal's Instructions for Contributors, and show credit to the sources in the Contribution.) The Contributor also warrants that the Contribution contains no libelous or unlawful statements, does not infringe upon the rights (including without limitation the copyright, patent or trademark rights) or the privacy of others, or contain material or instructions that might cause harm or injury.

H. INFRINGEMENT OF COPYRIGHT

If the copyright of the Contribution is infringed, the Contributor agrees that the Owner of the Journal may (without any obligation) take such steps as it considers necessary to deal with the matter. The Contributor will co-operate fully with the Owner of the Journal in any infringement proceedings and agrees to execute any documents and do any acts reasonably required by the Owner of the Journal for such purposes.

I. INFRINGEMENT OF COPYRIGHT

Nothing herein shall constitute or be considered to be a limitation upon a waiver of the privileges and immunities of the World Bank Group, which privileges and immunities are specifically reserved.

U.S. Government work

Note to U.S. Government Employees

A contribution prepared by a U.S. federal government employee as part of the employee's official duties, or which is an official U.S. Government publication, is called a "U.S. Government work", and is in the public domain in the United States. U.K. Government work (Crown Copyright)
